

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://conviviosociety.org> and Convivio and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Convivio include <https://conviviosociety.org>. The Convivio website is an arts, culture, and education organization site. By using the Convivio website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Convivio may collect personally identifiable information, such as your:

- First and Last Name

- Mailing Address

- E-mail Address

- Phone Number

If you purchase Convivio's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. Use of your Personal Information

Sharing Information with Third Parties

Convivio does not sell, rent or lease its customer lists to third parties.

Convivio may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party.

Convivio may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Convivio, and they are required to maintain the confidentiality of your information.

Convivio may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Convivio or the site; (b) protect and defend the rights or property of Convivio; and/or (c) act under exigent circumstances to protect the personal safety of users of Convivio, or the public.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Convivio. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Convivio website.
